## PLDO Partner Brian J. Lamoureux will be a Panelist at the RI League of Cities and Towns Workshop on Digital and Social Media Law for Municipalities

Staying up-to-date on current state and federal laws and being proactive in understanding this evolving area of the law is vital for public officials. I commend the Rhode Island League of Cities and Towns' leadership for holding this workshop for their members."
